

UCHealth School of Radiologic Technology

Tuition and Fees

1. <u>TUITION</u> - Tuition for the program is \$13,500.00/year for each year of the two-year program, for a total payment of \$27,000.00.

All students must pay \$4500.00 at the beginning of the first day of each semester. Registration for a semester is complete only after the check for payment of tuition and fees has cleared the bank. If a check is returned unpaid from the bank, UCHealth School of Radiologic Technology reserves the right to cancel the registration and/or submit the uncollectible check to the County Attorney for prosecution. A \$30 service fee will be charged on all returned checks. A late fee payment surcharge will also be assessed and payment will be required by cash or money order.

If a student does not pay \$4500.00 the first day of each semester, UCHealth School of Radiologic Technology reserves the right to drop the student from the respective term. As a result, students will not be allowed to continue the sequence of the program. It may not be possible for the student to re-enter the program in the future. If circumstances permit, the student's records will be reviewed and he/she may be admitted the following year pending faculty decision and as space is available.

2. <u>BOOKS and FEES</u> - Books, uniforms, markers, name tags, fees for the Registry Review Class, CSRT Convention, other travel, and the examination given by the American Registry of Radiologic Technologists are the responsibility of the student and not covered by the cost of tuition. These fees are non-refundable. An approximate breakdown of these costs is as follows:

REFUNDS

The policy of UCHealth School of Radiologic Technology in the event, and within thirty (30) days of the date, a student fails to enter the program, withdraws or had been discontinued therefrom, at any time prior to completion is as follows:

- 1. A full refund of all money paid if the school does not accept the applicant.
- 2. A full refund of tuition and fees paid if the applicant withdrew within three (3) days after signing the contract or making an initial payment, provided that the applicant has not commenced training.
- 3. A full refund of tuition and fees paid in the event that the school discontinues a course or program of education during a period of time within which a student could have reasonably completed the same, except that this provision shall not apply in the event that the school ceases operation.
 - 4. The refund will be calculated as of the last day of recorded attendance.
- 5. For the student that has begun classes a retention charge of \$150.00 will be assessed and the following refund of tuition will be:
 - a. 90% for the student terminating within the first 10% of their training.
 - b. 75% for the student terminating within 25% of their training.
 - c. 50% for the student terminating within 50% of their training.
 - d. 25% for the student terminating within 75% of their training.
 - e. No refund if greater than 75% of their training is completed.
 - f. Postponement of a starting date, whether at the request of the school or the student, requires a written agreement signed by the student, requires a written agreement signed by the student and the school. The agreement must set forth:
 - 1. Whether the postponement is for the convenience of the school or the student, and:
 - 2. A deadline for the new start date, beyond which the start date will not be postponed.

3. Refunds, if applicable, will be provided within 30-days of termination.

If the course is not commenced, or the student fails to attend by the new start date set forth in the agreement, the student will be entitled to an appropriate refund of prepaid tuition and fees within 30 days of the deadline of the new start date set forth in the agreement, determined in accordance with the school's refund policy and all applicable laws and rules concerning the Private Occupational Act of 1981.
