INTRODUCTION AND OVERVIEW

Introduction.

UCHealth Poudre Valley Hospital (PVH) and UCHealth Medical Center of the Rockies (MCR) aim to improve the lives of their patients by providing access to high-quality, comprehensive health care services. PVH and MCR have engaged many partners and organizations in the community to promote health and prevent illness in the local community with a focus on serving the community's most vulnerable populations. These efforts not only focus on providing emergency services and charity care, they also aim to develop and offer programs that promote health, prevent illness and ultimately address the social determinants of health. This report summarizes PVH and MCR's planned activities to support the identified community health needs.

UCHealth Poudre Valley Hospital and Medical Center of the Rockies overview.

PVH and MCR are both located in Larimer County, Colorado along with a broader network of UCHealth primary care and specialty care clinics. PVH is a 256-bed hospital that specializes in orthopedic surgery, neurosciences, cancer, bariatric weightloss surgery and women's and family services. MCR is a 191-bed, Level 1 trauma center with a full spectrum of services, specializing in heart and trauma care. MCR also provides women's services, critical care and general and robotic-assisted surgery and is home to LifeLine, UCHealth's emergency medical and critical care ground and air transport program. PVH and MCR are committed to improving the lives of the community's most vulnerable residents and cared for more than 207,000 inpatient admissions and outpatient visits for Medicaid patients during fiscal year 2024.

PVH and MCR are part of UCHealth, a Colorado-based health system that offers the most advanced care throughout the Rocky Mountain region, extending from Colorado to Wyoming and western Nebraska. As Colorado's only integrated community and academic health system, UCHealth is dedicated to improving lives and providing the highest-quality medical care with an exceptional patient experience. With more than 200 locations throughout the region, UCHealth pushes the boundaries of medicine, providing advanced treatments and clinical trials to ensure excellent care and outcomes for 2.8 million patients each year. UCHealth is also the largest provider of Medicaid services in Colorado, with more than 1.1 million inpatient admissions and outpatient visits for Medicaid patients during fiscal year 2024.

UCHealth's commitment to the communities we serve.

UCHealth is committed to improving lives and is proud to serve communities throughout Colorado and beyond. In fiscal year 2024, UCHealth provided \$1.3 billion in total community benefits, more than twice the nonprofit organization's tax benefits. UCHealth's community benefits include \$568 million in uncompensated and charity care to support uninsured and underinsured patients. The uncompensated care provided by UCHealth is more than any other health system or provider in Colorado.

Included as part of UCHealth's community benefit, PVH provided \$131 million in community benefits, including \$59 million in uncompensated care, during fiscal year 2024. Similarly, MCR provided \$125 million in community benefits and \$55 million in uncompensated care during the same period.

Community served.For the purposes of this implementation strategy, the PVH and MCR community is defined as Larimer County, which represents the geographic area most proximal to the hospitals where the majority of PVH and MCR patients reside.



IMPLEMENTATION STRATEGY

Implementation strategy process, development and approval.

The implementation strategy report for PVH and MCR is based on the findings and health issue priorities established through the 2025-2027 PVH and MCR Community Health Needs Assessment (CHNA).

Implementation strategy process.

An implementation strategy summarizes a hospital's plans to address identified community health needs and is intended to satisfy the requirements set forth in the Patient Protection and Affordable Care Act, passed in 2010. The implementation strategy process is intended to align the hospital's resources and programs with goals, objectives and metrics for how the hospital plans to address the identified health needs in the local community.

The implementation strategy was developed by the PVH and MCR Internal Advisory Group (IAG), a subset of the hospitals' leadership teams, which represents a broad range of departments and services across the organization. The development of the implementation strategy was based on an assessment of available community resources as well as a review of PVH and MCR's clinical support services, community health improvement programs and sponsorships and contributions to community organizations that aligned with identified health needs within the community.

The activities described in this report also rely on collaboration and partnerships with many of the same organizations and stakeholders that participated in the CHNA process. The listed strategies represent the combined input from key community leaders, public health experts, local health care providers and PVH and MCR leadership. A list of the organizations engaged during the CHNA and implementation strategy processes is included in the Appendix.

This report intends to describe hospital-based resources directed toward programs and services that will impact the priority health issues and are also aligned with federal community benefit guidelines for nonprofit hospitals. Given the ever-changing landscape of health care, the initiatives in this implementation strategy may change, and new ones may be added or others eliminated based on the community needs during 2026-2028. Initiatives are monitored for quality, performance and health impact with ongoing improvements made to facilitate success.

Boards of directors approval.

During the October 2025 meetings, the PVH and MCR Boards of Directors were apprised of and approved of this implementation strategy and related activities described within this report.

COMMUNITY HEALTH NEEDS

Identified community health needs.

PVH and MCR completed their 2025-2027 CHNA during the timeframe of December 2024 and March 2025. The CHNA process provided an opportunity for the hospitals to engage public health experts, medical providers and community stakeholders to collectively identify the most critical health needs within the community.

Assessment and prioritization process.

A multiphased approach was used to identify the top health priorities for future impact. The process included:

- A comprehensive analysis of local population health indicators.
- Solicitation of community input on local health issues through:
 - Distribution of a web-based survey to local community-serving organizations, school districts and government agencies.
 - A web-based survey distributed to health care providers at PVH and MCR to gather input on community health needs.
- Review of the most recent community health improvement plan for Larimer County as produced by Larimer County Department of Health and Environment.
- Participation in meetings with Larimer County Department of Health and Environment and other local organizations to gain insight into community needs.

The comprehensive list of opportunities was presented to PVH and MCR's IAG for consideration and was prioritized based on the following criteria:

- Scope and severity of the health need.
- Economic feasibility to address health need.
- Potential for PVH and MCR to impact health need.
- Alignment with UCHealth system strategies and local, state and national objectives.

Prioritized health issues.

The prioritized health issues identified for impact within the community served by PVH and MCR are access to care, behavioral health and chronic disease.

Tables addressing prioritized health needs.

The following tables outline strategies, initiatives, anticipated impact, potential collaborations and partners and resources the hospitals will commit to address the prioritized health needs. Unless otherwise noted, both hospitals participated in the programs and initiatives listed below, engaging in activities and contributing resources for the purpose of achieving the anticipated impact.

2026-2028 IMPLEMENTATION STRATEGY

Priority health issue: Access to care.

Goal: Improve access to comprehensive, quality health care services.

According to the County Health Rankings & Roadmaps (CHR&R) 2024 report, residents of Larimer County have reduced access to primary care advanced practice providers as compared to the state average, with one provider for every 710 residents as compared to one provider for every 650 Coloradans. Similarly, Larimer County experiences an unfavorable rate of uninsured persons compared to Colorado, with 7.2% of residents lacking health insurance as compared to 7.9% of Coloradans.

Research shows that access to primary care is associated with positive health outcomes. Individuals with an established primary care physician are more likely to receive recommended preventive services such as flu shots, blood pressure screenings and cancer screenings. Disparities in access to primary health care include language-related barriers, physical disabilities, inability to take time off work to attend appointments and transportation-related barriers.

Priority health issue: Behavioral health.

Goal: Improve identification, treatment or resource referral for individuals with behavioral health needs.

According to the U.S. Department of Health and Human Services, mental health disorders are among the most common causes of disability in the U.S. The resulting disease burden of mental illness is among the highest of all diseases.

According to the 2024 CHR&R report, Larimer County adults reported experiencing poor mental health over the past two weeks at a higher rate than Coloradans overall. Similarly, high schoolers in Larimer County reported suicidal ideation at a slightly higher rate than Colorado high schoolers overall, with 11.9% of Larimer County high school students reporting thoughts of seriously contemplating suicide as compared to 11.1% of Colorado high schoolers, per the 2023 Healthy Kids Colorado Survey (HKCS). The 2024 CHR&R report notes the suicide rate in Larimer County at 21 deaths per 100,000 population compared to 22 in the state of Colorado, both numbers well above the national average of 14.

The effects of substance use disorders are cumulative, significantly contributing to costly social, physical, mental and public health problems. The Centers for Disease Control and Prevention reports that binge drinking is the most common, costly and deadly pattern of excessive alcohol use in the U.S. Binge drinking is defined as a pattern of drinking that brings a person's blood alcohol concentration to 0.08 g/dL or above. This typically happens when men consume five or more drinks or women consume four or more drinks in about two hours. In Larimer County, 23.3% of adults report binge drinking, higher than the state average of 21.4% per the 2024 CHR&R data. Both numbers are higher than the national average of 19%. Elevated substance use is also reflected among high school students, with 14.9% of Larimer County high schoolers reporting binge drinking in the past 30 days as compared to 12.1% of Colorado high schoolers overall according to the 2023 HKCS data.

In addition to alcohol use, tobacco use is slightly more prevalent in Larimer County than across Colorado for both adults and youth according to 2024 CHR&R report (adults) and the 2023 HKCS (youth).

Priority health issue: Chronic disease.

Goal: Reduce the incidence, burden and associated risk factors related to chronic disease.

Chronic diseases are the leading cause of illness, disability and death in America. According to the CDC, most chronic diseases are caused by lifestyle choices such as smoking, poor nutrition, physical inactivity and excessive alcohol use. Adhering to recommended screening guidelines is effective at early detection of many types of chronic disease, particularly cancer.

Larimer County experiences a higher rate of chronic disease across a variety of conditions according to the 2021-2023 Colorado Health Indicators dataset. The rate of Alzheimer's disease is 34.9 per 100,000 population in Larimer County compared to 30.1 in Colorado. Similarly, the rate of cerebrovascular disease is 36.4 per 100,000 population in Larimer County compared to 33.7 across Colorado.

According to the 2018-2020 Colorado Health Indicators dataset, overall rates of cancer are also higher in Larimer County than across Colorado. For all cancer sites combined, the age-adjusted incidence rate is 411.3 per 100,000 population in Larimer County compared to 387.5 in Colorado. The age-adjusted incidence rate of breast cancer is 44.4 per 100,000 population in Larimer County compared to 41.1 in the state.
