

MANTENANCE GIVEAWAY RULES

OFFICIAL RULES

OVERVIEW:

Individuals who complete the online entry form are eligible to win a prize package that includes one (1) autographed Gabe Landeskog Jersey, one (1) autographed Trevor Story baseball and one (1) autographed Denver Broncos item. Entries will be accepted from November 1, 2019 through November 16, 2019 and three (3) winners will be selected by random on November 18, 2019.

ELIGIBILITY:

The Giveaway is open to legal residents of the United States including the commonwealths, territories and possessions who are eighteen (18) years of age or older at the time of entry.

Employees, officers, and directors of UCHHealth and their immediate families (parents, children, siblings, and spouse) and members of their household (whether or not related), who are involved in any aspect with the creation, production, operation, execution, and fulfillment of the Giveaway are not eligible to enter.

TO ENTER:

1. UCHHealth.org/MAN:
 - a. Individuals are required to complete an online entry form on dedicated landing page for the Giveaway no later than Saturday, November 15, 2019 at 11:59 PM MST to be considered for the Giveaway. Completion of the form within the Giveaway period will automatically enter you in the Giveaway.
 - b. Individuals must provide their first and last name, birthdate, email, and zip-code.

By entering the Giveaway, the entrant agrees to be bound by the terms of these Official Rules. UCHHealth (collectively, the "Promotion Entities") are not responsible for late, incomplete, void, corrupted, misdirected, or otherwise erroneous entries, or for any problems, malfunctions or technical difficulties that arise in the entry process. Any incomplete or incorrect entries will be void. Proof of submission will not be deemed to be proof of receipt by UCHHealth. Once submitted, all entries shall be the property of UCHHealth and will not be returned. All entries submitted in compliance with these Official Rules and not disqualified are considered "eligible entries."

All entries must be received by the entry deadline of Saturday, November 15, 2019 at 11:59 PM MST to be eligible. Individuals will be selected at random on Monday, November 18, 2019 at 12 PM MST by a representative of UCHHealth ("Random Drawing").

One (1) alternate individual will be randomly selected by UCHealth from among the remaining eligible entries if a selected winner: (i) does not comply with any other rule or condition of the Giveaway; or (ii) cannot accept or receive the prize for any reason.

The winner will be notified by UCHealth at the email address (in the sole discretion of UCHealth) provided at the time of entry within 5 days of the Random Drawing.

DISQUALIFICATION:

It is the individual's responsibility to ensure compliance in all respects with the official rules.
