

Spring League Youth Sports Giveaway Rules

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS YOUTH SPORTS GIVEAWAY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED BY LAW.

OVERVIEW:

Individuals who complete the online entry form are eligible to win a prize package that includes one (1) personalized, four (4) session, training package with UCHealth Sports Performance powered by Elite Speed. Entries will be accepted from March 1, 2020 through June 1, 2020 and five (5) winners will be selected by random on June 1, 2020.

ELIGIBILITY:

The Giveaway is open to legal residents of the United States including the commonwealths, territories and possessions who are eighteen (18) years of age or older at the time of entry.

Employees, officers, and directors of UCHealth and their immediate families (parents, children, siblings, and spouse) and members of their household (whether or not related), who are involved in any aspect with the creation, production, operation, execution, and fulfillment of the Giveaway are not eligible to enter.

TO ENTER:

- a. Individuals are required to complete an online entry form on dedicated landing page for the Giveaway no later than Monday, June 1, 2020 11:59 AM MST to be considered for the Giveaway. Completion of the form within the Giveaway period will automatically enter you in the Giveaway.
- b. Individuals must provide their first and last name, email, sports league and zip-code.

By entering the Giveaway, the entrant agrees to be bound by the terms of these Official Rules. UCHealth (collectively, the "Promotion Entities") are not responsible for late, incomplete, void, corrupted, misdirected, or otherwise erroneous entries, or for any problems, malfunctions or technical difficulties that arise in the entry process. Any incomplete or incorrect entries will be void. Proof of submission will not be deemed to be proof of receipt by UCHealth. Once submitted, all entries shall be the property of UCHealth and will not be returned. All entries submitted in compliance with these Official Rules and not disqualified are considered "eligible entries."

SELECTION:

All entries must be received by the entry deadline of Monday, June 1, 2020 11:59 AM MST to be eligible. Individuals will be selected at random on Monday, June 1 at 12 PM MST by a representative of UCHealth ("Random Drawing").

One (1) alternate individual will be randomly selected by UCHealth from among the remaining eligible entries if a selected winner: (i) does not comply with any other rule or condition of the Giveaway; or (ii) cannot accept or receive the prize for any reason.

The winner will be notified by UCHealth at the email address (in the sole discretion of UCHealth) provided at the time of entry within 5 days of the Random Drawing.

DISQUALIFICATION:

It is the individual's responsibility to ensure compliance in all respects with the official rules. The Sponsor reserves the right in its sole discretion to disqualify any individual who tampers with the prize claim possesses or the operation of the Giveaway; acts in violation of these official rules; or acts in an unsportsmanlike or disruptive manner; or with the intent to disrupt or undermine the legitimate operation of the sweepstakes, or to annoy, abuse, threaten or harass any other person. The total number of prizes that can be awarded is one (1) of the aforementioned prizes to one (1) winner each. The odds of winning depend on the total number of eligible entries received.

The prizes are non-transferable and non-assignable with no cash redemptions and no redemptions in any alternate form.

RELEASE:
