

**UCHEALTH FLAG FOOTBALL KITS SWEEPSTAKES (The “SWEEPSTAKES”)

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. PRIZE: Fifty (50) Total Prizes Will Be Awarded comprised of forty-nine (49) Flag Football Kits and one (1) Grand Prize Flag Football kit, Approximate Retail Value of the Flag Football Kit: \$151.00. Approximate Retail of Grand Prize Flag Football Kit: \$400. “Grand Prize” will be identical to all regular Flag Football Kits and will also include an autographed item.

PRIZE NOTIFICATION RESPONSE TIME: 24 hours from the time of issuance of Prize Notification (defined below) (the “**Required Response Time**”).

ELIGIBILITY: The Sweepstakes is open only to legal residents of the State of Colorado who are eighteen (18) years of age or older. RANDOM DRAWING: The potential winners of the Sweepstakes will be selected by random drawing on or about seven (7) days following the Sweepstakes End Date from among all eligible entries received.
